- 3. **Federal Grants**: Administered by federal agencies
- 4. **State Grants**: Administered by state agencies or state governments.
- 5. **Private Grants**: Administered by private foundations. These grants usually do not have a deadline or accept applications throughout the year.
- 6. **Matching share**: The grantor is requesting the grantee to match the funds awarded. For example, the grantor is willing to give Korean Church of Memphis \$30,000 if the Korean Church of Memphis can match this amount.
- 7. **Reimbursement**: The grant funds are awarded after the work is completed.
- 8. **Ongoing:** Grant awards are made throughout the year. Typically, these foundations meet on a quarterly basis.

### Women of Worth Awards to USA Women for Exemplary Community Service Projects that have Ignited Social Change

**Agency Type:** Foundation / Corporation

Funding Source: L'Oreal Paris, administered by Points of Light

**Deadline:** 04/29/16 11:59 PM ET

**Description:** Awards of up to \$35,000 to USA women in recognition of outstanding volunteer efforts to serve their communities. These awards will recognize women who are selflessly creating a change in their community. The funding source will make a \$10,000 donation on behalf of each Honoree to a charitable organization of her choice (see official rules).

Also, each will be given an all-expense paid trip to New York City (\$1,400 maximum of travel and hotel accommodation) to be recognized at an Awards event.

Additionally, one National Honoree with the most online shares will receive an additional \$25,000 donation to her cause. All Honorees will receive national recognition for her cause and volunteer efforts.

Nominations will be organized into five groups by decades: 18-29-year-olds, 30-39-year-olds, 40-49-year-olds, 50-59-year-olds, 60+-year-olds.

Number of Grants: 10

**Estimated Size of Grant:** Each winner receives \$10,000. One National honoree receives an additional \$25,000.

**Eligibility:** Award Nominees must be women; legal residents of the 50 United States or the District of Columbia; consent to be nominated and 18 years of age or older at the time of nomination.

All volunteer activities of the Nominee must be unpaid and cannot include court-ordered community service, however, nominees who receive a nominal stipend for their service (such as in connection with a national service program such as AmeriCorps and Peace Corps) may be eligible. The nominee's volunteer activities must have occurred in the continental United States and have primarily benefited domestic American needs. To be eligible, the volunteer activity should have lasted for at least six uninterrupted months and should be ongoing.

### \*Self-nominations are permissible and encouraged.

All Honorees will be notified by telephone in mid to late September 2016. The National Women Of Worth Honoree will be announced at the celebration event in November 2016.

The Foundation's primary interests within Education include programs that focus on formal K-12 education (particularly mathematics, science and reading), teacher development, literacy, and higher education.

Within Community, the Foundation supports a broad range of human services, community improvement, abuse prevention, and youth development programs. Human service programs of particular interest to the Foundation include children and family services, early childhood development, and parenting education. The Foundation supports a variety of Community Improvement programs including those that enhance non-profit management and promote philanthropy and voluntarism. Youth development programs supported by the Foundation typically include after-school educational enrichment programs that supplement and enhance formal education systems to increase the chances for successful outcomes in school and life. The Foundation is also interested in programs that attract female and minority students into the fields of mathematics, science, and technology.

The Foundation's current interests in the area of Health/Medicine include programs that promote the health and well-being of children, programs that promote access to health services, and Foundation-initiated programs focusing on ALS.

Although there are no geographic restrictions to the Foundation's grantmaking program, the Foundation no longer accepts unsolicited requests for international agencies or programs. While the Foundation occasionally awards grants for operating expenses, capital campaigns, endowments, and international projects, such grants are infrequent and usually initiated by the Foundation. Multiyear grants are rare; most grants are awarded for a one-year period.

Eligibility: Grants are made only to nonprofit organizations certified as tax exempt under Sections 501(c)(3) or 170(c) of the Internal Revenue Code and are classified as "not a private foundation" under Section 509(a). Hospitals, educational institutions, and governmental institutions meeting these requirements are eligible to apply. Organizations that have completed and filed Form 1023 but not yet received an IRS determination letter are not eligible to apply. The Foundation does not make grants or loans to individuals.

### Limitations: As a general practice, RGK Foundation refrains from funding:

- Annual funds, galas, or other special-event fundraising activities
- Capital campaigns/renovation projects
- Debt reduction
- Emergency or disaster relief efforts
- Dissertations or student research projects
- Indirect/administrative costs
- Sectarian religious activities, political lobbying, or legislative activities
- Institutions that discriminate by race, creed, gender, or sexual orientation in policy or practice
- Loans, scholarships, fellowships, or grants to individuals
- Unsolicited requests for international organizations or programs
- Unsolicited requests for ALS research projects

# James Cox Foundation Grants for Conservation, Environment, Early Childhood Education, Empowering Families and Individuals for Success, & Health

The James M. Cox Foundation provides philanthropic support for not-for-profit organizations in communities where Cox Enterprises, Inc. does business. The Foundation is concentrating its community support in several priority areas:

Two types of support are considered:

- Organizations <u>located outside of metropolitan Atlanta</u>, <u>Georgia</u> must have a letter of endorsement from a local Cox business leader to submit along with the application for consideration.

#### Limitations

Only one request will be considered per organization during a 12-month period. For example, if a request is submitted in March, whether it is approved or declined, another request will not be considered until the following March.

Grants are limited to public charities when it is demonstrated that the proposed project or program will have a particular impact in one of our focus areas. We do not make grants to
